Introduction: We respect consumers' constitutional rights to privacy and data protection. This Privacy Policy explains how Pilats Stance, LLC. ("we/us") collects, uses and disclosures your personal information with respect to your use of our website, www.pilates-stance.com.

Definition of Personal Information: "Personal information" means information that specifically identifies an individual (such as a name, address, telephone number and email address), or information about that individual that is directly linked to personally identifiable information. Personal information does not include "aggregate" information, which is data we collect about the use of our websites or about a group or category of services or users, from which individual identities or other personal information has been removed. This Privacy Policy in no way restricts or limits our collection and use of aggregate information.

Collection of Personal Information: We may collect information about you in various ways when you use our websites.

We treat this information as personal information if we combine it with, or link it to, any of the personally identifying information mentioned in the section above entitled "Personal Information". Otherwise, it is used only in the aggregate.

Use of Personal Information: We use personal information collected through our websites for the purposes described in this Privacy Policy or elsewhere on our websites. For example, we may use personal information we collect:

- for purposes of shipping products to you;

We are not responsible for the actions of third party service providers, nor are we responsible for any additional information you provide directly to these parties, and we encourage you to become familiar with their practices before disclosing information directly to them. Nothing herein restricts the sharing of aggregate information of any kind, which may be shared with third parties without your consent.

Efforts to Protect Personal Information: We take reasonable measures to protect your personal information in an effort to prevent loss, misuse, and unauthorized access, disclosure, alteration, and destruction. However, despite our efforts, no security measures are perfect or impenetrable and no method of data transmission can be guaranteed against any interception or other type of misuse.
